JOB CONTEXT

WWF-UK recognizes that over the next twenty to fifty years, growth in China, Russia, Brazil, India and other countries in the 'South' will outstrip the US and other major economies and the centre of gravity of the world, in terms of both economic and political power, will move South. The developmental impact of these countries elsewhere in the world - for example, the impacts of Chinese investment in Africa – will be of critical importance. In order for the WWF Network to be able to respond to the changing world, we need to develop coherent strategies to addressing the threats and opportunities that these huge economic changes will present. We need to work towards a coherent Network-wide response to these problems, drawing on increased capacity particularly in policy development and delivery in our Southern partners.

In response WWF-UK is supporting the development of the China Africa strand of the China for Global Shift, Coastal East Africa and Green Heart of Africa Network Initiatives. In China, the China Africa programme of work encourages Chinese leadership for sustainable development through the supporting key Government and private sector actors, particularly Chinese banking sector, to develop outward investment policies that promote internationally recognized environmental and social standards. While in Africa the programme works with key Governments to put in place policies, strategies, processes and capacity to ensure that future investments bring widespread benefits, contribute to poverty reduction and promote environmental sustainability.

The China / Africa Programme Manager will work to support the three network initiatives to develop and implement the Africa China strategy by providing technical advice, securing funding and establishing relevant partnerships.
