SAVE THE WORLD'S FORESTS AND WILDLIFE

A simple enough request, you might think. But we know exactly how tough it is to achieve.

WWF HAS SPENT THE LAST 53 YEARS REMINDING THE WORLD THAT WE SHOULD LOOK AFTER OUR NATURAL RESOURCES AND WILDLIFE. WWF has spent the last 53 years reminding the world that we should look after our natural resources and wildlife. But it's gone beyond the gentle reminder stage now.

Most people already know what should be done. The scientific evidence is clear – vast swaths of frankly irreplaceable natural forests (essential for a healthy biosphere) are still disappearing every day. Huge numbers of animal and plant species are still being wiped out, every week – some before their identity, or value, is even known. Here's what the next government can do:

- Close the loopholes that still allow illegal or unsustainable wood products to be sold in Europe. There's a review of the EU Timber Regulation in 2015 that's the key chance to get this right.
- Insist that crimes against wildlife such as butchering elephants for ivory or smuggling tiger parts are treated as the serious offences they are. In the UK we need long-term funding for our vital National Wildlife Crime Unit.



BUILD A CLEAN, 21ST CENTURY ECONOMY - AND DO WHAT WE PROMISED ON CLIMATE CHANGE.

Lack of knowledge isn't the problem here – the scientific consensus on climate change is overwhelming. Burning fossil fuels and cutting down forests have been messing with the planet's fragile atmosphere, and dangerously warming the Earth.

The UK led the world with the Climate Change Act in 2008, but we need to maintain that leadership now. We can't wait for someone else to do it, and we are in a great position to push for meaningful action in Europe and globally. Here's what the next government can do:

- Confirm solid commitments and targets for slashing our greenhouse gas emissions. The Committee on Climate Change has worked out the figures in its 'carbon budgets' politicians now need to put them into practice.
- Be serious and ambitious about backing renewable energy and make energy efficiency of homes our national infrastructure priority. We can and must 'de-carbonise' the UK's economy, moving away from the old dependency on dirty fossil fuels for our energy and transport. We must encourage EU and global economies to do the same.
- Promote and support sustainable development at home and abroad.

 We need a new Office of Environmental Responsibility to hold the government to account on its environmental performance, putting action on the environment and climate change at the heart of policy.

We're an island nation, and it rains a lot – but we haven't done as good a job as we should have of looking after the natural resources this gives us.

We waste far too much precious fresh water, we've let some of our once-thriving fish stocks decline, and we need to make better progress on protecting our best marine sites. Here's what the next government can do:



- Create a coherent network of protected areas in the seas around the UK safeguarding some of our most precious wildlife.
- Prevent too much water being taken from our rivers, and restore damaged ones to health. And insist that businesses and households use water much more efficiently much greater use of water meters will help.
