









## **ALLIANCE FOR COMMON FISHERIES POLICY REFORM**

European associations from the processing and trading, consumer co-operative and retail sectors, chefs and WWF

Plenary vote on October 23<sup>rd</sup> 2013 on the EU Maritime and Fisheries Fund (A7-0282/2013 - 2011/0380(COD)) Rapporteur: Alain Cadec (EPP)

AIPCE-CEP, EUROCOMMERCE, EURO COOP, EURO-TOQUES INTERNATIONAL and WWF have a shared vision for sustainable European fisheries and have been working together for an ambitious reform of the Common Fisheries Policy (CFP) as the *Alliance for Common Fisheries Policy Reform*. We follow closely the discussions on the future European Maritime and Fisheries Fund (EMFF). We believe that this reform will only be successful if future fisheries subsidies are efficiently targeted to achieve the new CFP's objectives and to support its implementation.

In February 2013, the European Parliament facilitated the shift towards sustainable fisheries management with its historic vote in favour of a new CFP. The upcoming plenary vote on the EMFF is a unique opportunity for the European Parliament to ensure that this policy shift is substantiated with the right financial instrument, which provides for:

## 1. Increased funding for data collection and for control and enforcement

We are highly concerned by the fact that the proposed funds earmarked for data collection and control and enforcement are not sufficient to ensure a transition towards a long-term economic, social and environmental sustainable fishing sector in the EU. Effective implementation of the new CFP is highly dependent on both enhanced control and enforcement and data collection to gather solid knowledge of the ecosystem and fisheries activities.

We urge Members of the European Parliament to vote for an EMFF that provides for increased funding for measures that improve data collection, control and enforcement as these are vital preconditions for sustainable fisheries management and for providing a fair level playing field. Priority should also be given to research and measures which foster sustainable fishing practices such as improved gear selectivity.

## 2. Equal opportunities for all stakeholders to support the implementation of the Common Fisheries Policy

All stakeholders, including Member States, fishermen, industry, scientists, consumer an environmental interests, must be at the heart of the decision making process. Advisory bodies should be composed of representatives of all interest groups affected by the Common Fisheries Policy. To ensure a balanced representation and participation of stakeholders in regional management processes, we urge Members of the European Parliament to vote for an EMFF that foresees support for the involvement and participation of all relevant stakeholders.

The future EMFF should also support stakeholder involvement in the process of setting up Multiannual Management Plans for all European fisheries.
